John called the meeting to order at 7:00pm.

MINUTE APPROVAL

John motioned to approve the Work Session Meeting minutes of June 3, 2025 as written, Tony 2nd, so voted.

John motioned to approve the Non-Public Work Session Meeting minutes of June 3, 2025 as written, Tony 2nd, so voted.

John motioned to approve the Select Board Meeting minutes of June 3, 2025 as written, Tony 2nd, so voted.

NEW BUSINESS:

Local Septic Approval Map 7 Lot 57

The septic designer emailed a local septic approval and septic plan for Map 7 Lot 57. They are installing a new septic. All information is correct. **John motioned to sign the local septic approval for Map 7 Lot 57, Tony 2nd, so voted.**

Amended Local Septic Approval Map 2 Lot 9

The septic designer dropped off another amended local septic approval and septic plan for Map 2 Lot 9. They had to make a few more changes. All information is correct. Sara had brought the meeting minutes from June 18, 2024 where the Select Board had approved that the septic would intrude about 2-4 feet into the 25-foot set back and would be in the towns right of way. Now it appears to be more into the right of way and set back than was approved and the entire leach field is in the 25-foot set back. John said we should have them submit a waiver that states that the Town will not be liable to replace the septic or leach field if anything happens to it while be plowed, road work, etc. because it is within the Towns right of way. **John motioned to table the amended local septic approval for Map 2 Lot 9 until the waiver is received, Tony 2nd, so voted.**

Amended Septic Plan Map 6 Lot 1-3

The septic designer dropped off an amended septic plan for Map 6 Lot 1-3. They had to make a few changes. All information is correct. There is no local approval form so the Select Board will just sign the plan and we will stamp it with the town stamp. **John motioned to sign the amended septic plan for Map 6 Lot 1-3, Tony 2nd, so voted.**

Intent to Cut- Map 2 Lot 93

The owner submitted an intent for Map 2 Lot 93 for the property located on North Groton Road. This is about a 3.5- acre cut. No bond is needed. **John motioned to sign intent to cut for Map 2 Lot 93, Tony 2nd, so voted.**
